Entries must include entry fee. No refunds after names are placed in the draw.

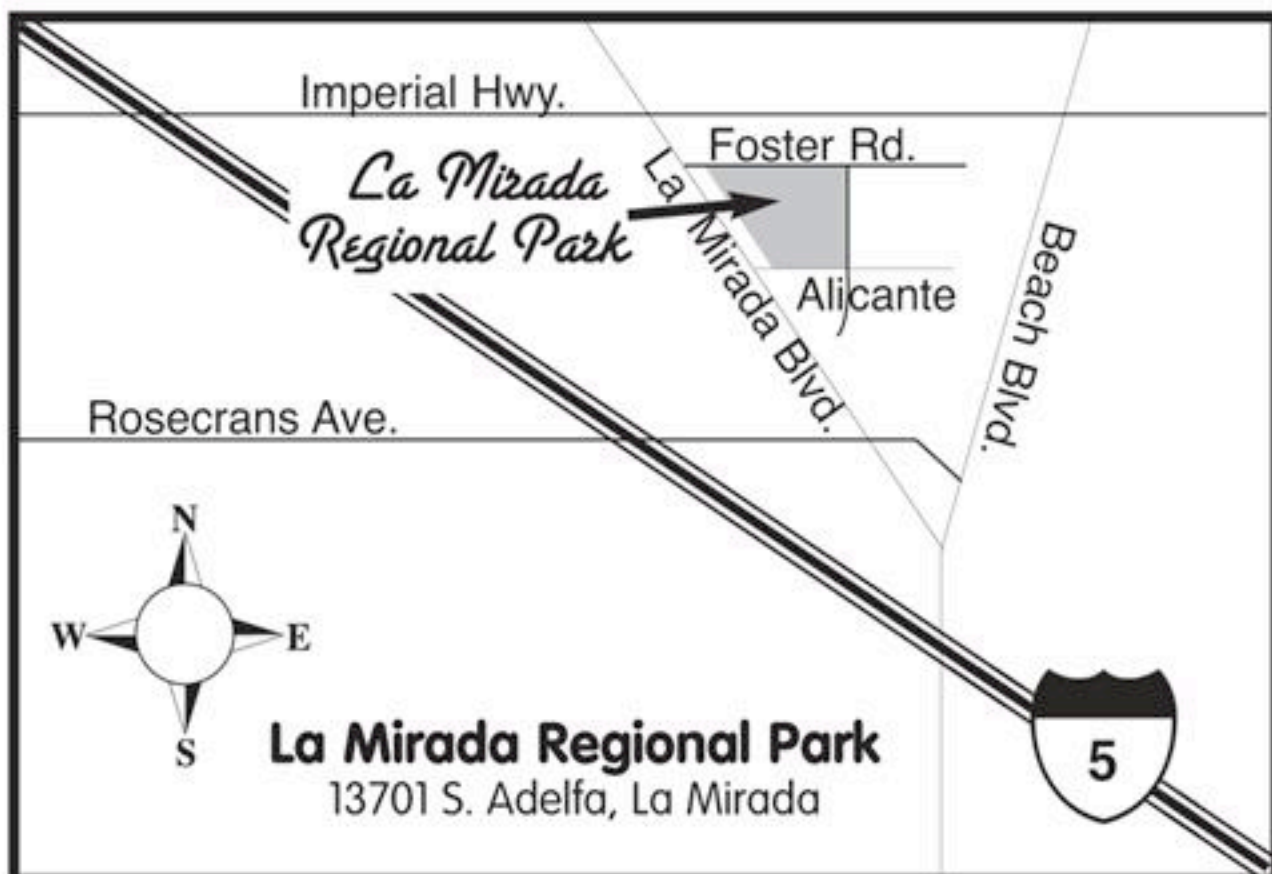
